TADLOCK ROOFING, INC.'S #TADLOCKGOESGREEN – INSTAGRAM SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR INTERNET ACCESS NECESSARY TO PARTICIPATE

- 1. Eligibility. Tadlock Roofing Instagram Sweepstakes (the "Sweepstakes") are offered only in the state of Florida to individuals who are legal residents of both Florida and the United States and who are at least twenty-one (21) years of age. Employees and directors of Tadlock Roofing, Inc. and Owens Corning ("Sponsors"), and the parents and subsidiary companies and the immediate family (spouse, mother, father, sister, brother, daughter or son, regardless of where they live) or members of their same households (whether related or not) of such employees and directors are not eligible. - (b) Mail-In Method
- (1) All Mail-In entries must be Postmarked prior to October 21, 2017 to be considered valid entries.
